3. Applicant hereby authorizes Vacuum Truck Rentals, L.L.C. (i) to rely upon and verify said credit and business information, (ii) to obtain consumer and/or commercial credit reports on the signer(s) and Applicant; and (iii) to provide credit information about Vacuum Truck Rental, L.L.C.'s credit experience with the signer(s) and the Applicant to other creditors and to credit reporting agencies, from time to time.
